- A deep dive will be completed in the Strategic Risk Register (SRR) now we have a new Police and Crime Plan to ensure all foreseeable risks are documented.

## Freedom of Information (FOI)/Data Protection Requests

FOIs continue to come in and be managed by BC.

## Independent Custody Visitors (ICV) / Dog Welfare Scheme

- ICV Panel held on 26 September 2024 via Teams introduced TDC who will be covering as Scheme Manager whilst BC is on maternity leave.
- Training on using iPads/tablets for custody visits was delivered and well received. We hope to go live from 1<sup>st</sup> October 2024.
- We have introduced a new way of signing up to visits via using a Microsoft Form to select availability for the next quarter.
- 3 new starters which takes our numbers to 29 in total, one new ICV currently undergoing vetting.
- We have attended both Bedford and Luton University Freshers Fayres and promoted our panels. This was extremely successful, and we have a lot of students interested. Next steps are to contact them and book them in for interviews.



# Stop and Search/Use of Force Scrutiny Panel

- Recent Bulletin produced.
- Data panel starting 29th October.
- We have taken on the Section 163 scrutiny panel and held our first training session on the 19th of September 2024. We are currently creating a training pack and quiz to be given to those who were unable to make the training.
- A Red, Amber, Green (RAG) traffic light system workshop has been arranged and invites have been sent out to all panel members. This will be held on the 8th of October 2024.
- We have attended both Bedford and Luton University Fayres and promoted our panels. This was extremely successful, and we have a lot of students interested. Next steps are to contact them and book them in for interviews.
- Regarding recruitment of volunteers, we recently had a successful interview and are in the process of booking them in for training.

# **Independent Custody Detention Scrutiny Panel (ICDSP)**

- Recent bulletin produced and published.
- Last meeting focused on Juvenile Strip Search areas identified for learning passed to Chief Inspector.
- Pilot review been sent out and responses will be accumulated and reflected upon.

### **Legally Qualified Chairs (LQC)/Misconduct**

On 7<sup>th</sup> May legislation changed surrounding LQC and Independent Members so new process is in place to ensure we are complying with this.

## **Pension Forfeiture**

Awaiting update on five cases from the Force. Once received packs will be made and brought to the PCC for a determination if pension forfeiture should be completed.

### **Police Appeals Tribunal**

Four finalised and one due to complete in October 2024.

### **Complaints**

Work is being completed in this area – Dip Sampling and liaising with the Force. Team will now have additional working group updates with force CS.

Reviews – Three completed and one outstanding.



There is no time frame for a review to be completed however the aim is to complete as soon as practicable.

# Website Compliance - Specified Information Order

SD and BC are working on the retention policy and clearing files – this is still ongoing. Moving forward we will be looking at SharePoint and how we get the office moved over and using this system.

Website: meeting been had with Single Online Home (SOH) and initial barriers have now been completed so the next phase will be taking place on 1<sup>st</sup> October 2024. We will require all team members to assist by ensuring that their areas are updated. Due to timeline, we may be looking at Jan 2025 for launch.

# **Violence & Exploitation Reduction Unit (VERU)**

As of September 2024, the Home Office have not confirmed the funding arrangements for the VRU programme post March 2025. The VERU remain in regular communication with Bedfordshire's Single Point of Contact (SPOC) within the Home Office, who have indicated that there is appetite to continue to support the programme nationally. However, confirmation of what this may look like going forward can only be finalised and shared following the budget and spending review set for October 2024. The VERU's Head of Service is set to attend the VRU Director's Conference, hosted by the Home Office on 23rd September 2024 where further information is expected to be provided.

In line with the change in operating model for 2024/25, the VERU set up a suite of new interventions, aimed at responding to the findings and recommendations contained within our Strategic Needs Assessment (SNA). This year sees the largest amount of VERU funding allocated to the rollout of these programmes, as well as supporting our statutory partners in their work to prevent serious violence and exploitation.



Collection and analysis of data at the end of Q1 indicates positive performance across the board in relation to VERU / partnership interventions.

Integrating community and young person voice into the work that we do, continues to be a priority for the VERU. We have recently developed upon our existing VERU Village, creating our Youth Voice Fund. This opportunity was created with the aim of increasing engagement with our young people in the VERU and wider partnership.

Following a procurement process, Att10tive, as the successful organisation, has collaborated with the VERU to set up our youth forum, named POWER Youth Action and will work to support the core VERU team.

The Centre for Crime Justice and Policing at the University of Birmingham have now been commissioned to undertake an impact evaluation of the VERU 24/25 Navigators Schemes. These types of interventions are becoming increasingly recognised across the VRU network nationally. The aim is therefore to have a robust evaluation of our interventions on a local level, to aid learning, development moving into future rounds of funding. In addition, they will further carry out an in-depth analytical understanding of the entire VERU at a local level. This will require a review at a strategic level to understand how integrated services planned and delivered in the local area are being delivered. Additionally, it will enable to understand how the capacity and capability of the VERU have developed over time.

### Commissioning

The Commissioning and Income Generation Lead is due to leave the role on 11<sup>th</sup> October 2024.

The Commissioning Team are preparing for quarter 2 monitoring meetings in October. The new monitoring return templates will continue to be used to inform system thinking and wider discussions on themes. Outcomes and outputs will be gathered into a Governance and Transparency presentation to share activity from within quarter 2, this meeting is scheduled for 19th November 2024.

A research provider continues to progress the independent needs assessment which continues into 2024/2025. The interim report is due to be submitted soon, date pending.

The Commissioning team presented to the Police and Crime Commissioner on commissioning activities and their alignment to current, short-term, and long-term goals within the Police and Crime Plan for Bedfordshire Police.

Commissioning activities are underway regarding two tender opportunities, Domestic Abuse Independent Advocate (IDVA) and Programme of Therapeutic Response and



Sexual Violence Independent Advocate (ISVA) and Programme of Therapeutic Response.

During the process of developing the specification for the ISVA service, a decision was made to collaborate with Essex Police and Crime Commissioner's Office, preparing a joint specification.

The IDVA specification was released to bid respondents on 5<sup>th</sup> August 2024 and the ISVA specification was released to bid respondents on 2<sup>nd</sup> September 2024.

The IDVA tender opportunity closed on 9<sup>th</sup> September and the bids are currently being evaluated. The ISVA tender opportunity is due to close on 7<sup>th</sup> October.

The Commissioning team are working on an options paper which will lay out to The PCC the funding options and risks for 2024/2025 and beyond.

The Commissioning team have explored opportunities for income generation in terms of accessing funds, self-generated funds from commissioned services, collaboration and approaching organisations regarding social value expectations. Scoping is ongoing to understand external opportunities for funding and how other OPCCs manage income generation, however initial findings suggest that the main source of income generation will remain focused on governmental funds.

# **Restorative Justice (RJ) Coordinator**

## Office Update:

AP is now back to work full time after being off for maternity leave.

#### Referrals:

1 new referral and 1 enquiry since last BRM.

4 cases actively working on, 1 on hold.

### **Prison project:**

Dates for Train the Trainer course have been set for 29<sup>th</sup> October and 5<sup>th</sup> November.

#### Schools project:

The last of the roleplays were delivered.



Plans are still being put in place for each school to see how they want to use restorative approaches in the new school year.

### **Training:**

The team will be delivering an awareness session to Emerald on the 4<sup>th</sup> of October. Training dates for the Out of Court Resolution Team have also been booked for the end of October.

An intranet article went out to highlight the training work the team have been doing. Off the back of this, Community Policing got in touch and scheduled in training dates for the team.

#### Links:

Work is being done around tracking referrals and information given by the police to victims. This is being done with the Victim Tactical Lead and Analyst. A page on PowerBI will be created under Victims Code of Practice (VCOP) which will hold the Force to account.

Links with the probation still continue with drop-ins being delivered at the Luton and Bedford offices. The drop-in sessions were well received and had some positive conversations.
